


# Malaffi Provider Portal Quick Reference Guide Family & Social History

Family and Social History is now available in the Malaffi Provider Portal, offering a more complete view of each patient's health background.

This enhancement supports chronic disease management by identifying genetic and environmental risk factors. By enabling early identification of potential health risks, it enhances risk management and improves risk stratification. Clinicians can now prioritise care based on the likelihood of patients developing specific conditions, leading to more personalised and effective healthcare.



Family & Social History

**1** **Accessing Family and Social History**

- Open the patient Malaffi file through your EMR.
- Navigate to the CDV on Delta view or Patient Summary tab and select **Family & Social History** folder
- View the required fields and select the magnifying glass beside each item for more information

**2** **Family History**

The Family History field displays the health history of the patient's family members, organised by individual family members (e.g., mother, father). Each entry includes the family member's relationship to the patient, gender, a description of their health history, the presence of conditions (Yes/No), and the source of the information.

If a family member has multiple conditions or the same condition entered at different facilities, they will be consolidated by history description (a coded field). Select the magnifying glass 🔍, to view all health history of the family member. The most recent information will display in the main window.

**Note:** Some family history information may be marked as sensitive and require the user to "Break the Privacy Seal" (BTS) to access the information. Follow the BTS prompts to access the information. This is indicated by the open padlock 🔒.

**3 Social History**

Social History contains multiple fields including:

- Smoking History
- Alcohol Drinking (Sensitive information)
- Substance Abuse (Sensitive information)
- Education Level
- Employment Status
- Physical Activity

**Note:** Some social history fields are marked as sensitive and require the user to 'break the privacy seal (BTS)' to access the information.

## Social History Fields

**Smoking History:** Displays the patients smoking history by device, including date, status, device, age of commencement/cessation, frequency, and source. Multiple entries for the same device from different facilities are consolidated and accessible via the magnifying glass.

**Alcohol Drinking:** Displays the patients Alcohol history by drinking status, including date, status and source. Multiple entries with the same status are consolidated and accessible via the magnifying glass.  
**Note:** Alcohol drinking history is sensitive information and requires the user to BTS to access the information.

**Substance Abuse:** Displays the patient's substance abuse history by status and includes date, substance abuse status and source. Multiple entries with the same status are consolidated and accessible via the magnifying glass.  
**Note:** Substance Abuse history is sensitive information and requires the user to BTS to access the information.

**Education Level:** Displays the patient's education history including date, education level and source of information. Multiple entries with the same education level are consolidated and accessible via the magnifying glass.

**Employment Status:** Displays the patient's employment history by employee status including date, employment status and source of information. Multiple entries with the same employment status are consolidated and accessible via the magnifying glass.

**Physician Activity:** Displays the patient's physical activity history by activity type and includes date, activity type, frequency (Day/week), duration (mins) and source. Multiple entries of the same activity will be consolidated and accessible via the magnifying glass.
